Privacy Policy

Sodexo Limited ("We") are committed to protecting and respecting your privacy.

This policy together with our terms of use sets out the basis on which any personal data We collect from you, or that you provide to us, will be processed by us. Please read the following carefully to understand our views and practices regarding your personal data and how We will treat it.

For the purpose of the General Data Protection Regulations (GDPR), the data controller is Sodexo Holdings Limited of One Southampton Row, London WC1B 5HA.

Information We may collect from you

We may collect and process the following data about you:

- Information that you provide by filling in forms on our site or entering into any competition, promotion or survey including identity and contact information on <https://www.eventsatbhafc.co.uk> (our site) or during telephone calls with us. This includes information provided at the time of registering to use our site, subscribing to our service, posting material requesting further services, making enquiries in relation to our services or booking an event by telephone. We may also ask you for information when you report a problem with our site.
- If you contact us, We may keep a record of that correspondence and may send marketing materials to you from time to time.
- We may also ask you to complete surveys that We use for research purposes, although you do not have to respond to them.
- Details of transactions you carry out through our site or by telephone and of the fulfilment of your orders.

- Details of your visits to our site or telephone calls with us including, but not limited to, traffic data, location data, weblogs and other communication data, whether this is required for our own billing purposes or otherwise and the resources that you access.

IP addresses and cookies

We may collect information about your computer, including where available your IP address, operating system and browser type, for system administration and to report aggregate information to us or our partners. This is statistical data about our users' browsing actions and patterns, and does not identify any individual.

For the same reason, We may obtain information about your general internet usage by using a cookie file which is stored on the hard drive of your computer. Cookies contain information that is transferred to your computer's hard drive. They help us to improve our site and to deliver a better and more personalised service.

They enable us:

- To estimate our audience size and usage pattern.
- To store information about your preferences, and so allow us to customise our site according to your individual interests.
- To speed up your searches.
- To recognise you when you return to our site.

You may refuse to accept cookies by activating the setting on your browser which allows you to refuse the setting of cookies. However, if you select this setting you may be unable to access certain parts of our site. Unless you have adjusted your browser setting so that it will refuse cookies, our system will issue cookies when you log on to our site.

Where We store your personal data

The data that We collect from you may be transferred to, and stored at, a destination outside the European Economic Area (EEA). It may also be processed by staff operating outside the EEA who work for us or for one of our suppliers. Such staff may be engaged in, among other things, the fulfilment of your order, the processing of your payment details and the provision of support services. By submitting your personal data, you agree to this transfer, storing or processing. We will take all steps reasonably necessary to ensure that your data is treated securely and in accordance with this privacy policy.

All information you provide to us is stored on our secure servers. Any payment transactions will be encrypted using SSL technology. Where We have given you (or where you have chosen) a password which enables you to access certain parts of our site, you are responsible for keeping this password confidential. We ask you not to share a password with anyone.

Unfortunately, the transmission of information via the internet is not completely secure. Although We will do our best to protect your personal data, We cannot guarantee the security of your data transmitted to our site; any transmission is at your own risk. Once We have received your information, We will use strict procedures and security features to try to prevent unauthorised access.

Legal ground for processing and uses made of the information

We process your personal data for any of the following reasons:-

- for the performance of a contract to which you are party;
- for Sodexo's legitimate interests except where such interests are overridden by your interests or fundamental rights and freedoms; or
- because you have given us consent to do so.

We use information held about you in the following ways:

- To ensure that content from our site is presented in the most effective manner for you and for your computer.
- To provide you with information, products or services that you request from us or which We feel may interest you, either where you have consented to be contacted for such purposes or where We have another legal ground for contacting you.
- To carry out our obligations arising from any contracts entered into between you and us.
- To allow you to participate in interactive features of our service, when you choose to do so.
- To notify you about changes to our service.

We may also use your data, or permit selected third parties to use your data, to provide you with information about goods and services which may be of interest to you and We or they may contact you about these by post, electronic means (e-mail or SMS) or telephone.

If you are an existing customer, We will only contact you by electronic means (e-mail or SMS), post or telephone with information about goods and services similar to those which were the subject of a previous sale to you.

If you are a new customer, and where We permit selected third parties to use your data, We (or they) will contact you by electronic means (e-mail or SMS), post or telephone only if you have consented to this.

We will only pass on your details to third parties where We have received your consent. You have the right to withdraw your consent at any time.

Disclosure of your information

We may disclose your personal information to any member of our group, which means our subsidiaries, our ultimate holding company and its subsidiaries, as defined in section 736 of the UK Companies Act 1985.

We may disclose your personal information to third parties:

- In the event that We sell or buy any business or assets, in which case We may disclose your personal data to the prospective seller or buyer of such business or assets.
- If Sodexo Limited or substantially all of its assets are acquired by a third party, in which case personal data held by it about its customers will be one of the transferred assets.
- If We are under a duty to disclose or share your personal data in order to comply with any legal obligation, or in order to enforce or apply our terms of use and other agreements; or to protect the rights, property, or safety of Sodexo Holdings Limited and/or its subsidiary and associated companies, our customers, or others.

This includes exchanging information with other companies and organisations for the purposes of fraud protection and credit risk reduction.

Your rights

Sodexo is committed to ensure protection of your rights under applicable laws. You will find below a table summarizing your different rights:

Right of access	<p>You can request access to your personal data. You may also request rectification of inaccurate personal data, or to have incomplete personal data completed.</p> <p>You can request any available information as to the source of the personal data and you may also request a copy of your personal data being processed by Sodexo.</p>
Right to be forgotten	<p>Your right to be forgotten entitles you to request the erasure of your personal data in cases where:</p> <ul style="list-style-type: none"> (i) the data is no longer necessary; (ii) you choose to withdraw your consent;

	<ul style="list-style-type: none"> (iii) you object to the processing of your personal data by automated means using technical specifications; (iv) your personal data has been unlawfully processed; (v) there is a legal obligation to erase your personal data; (vi) erasure is required to ensure compliance with applicable laws.
Right to restriction of processing	<p>You may request that processing of your personal data be restricted in the cases where:</p> <ul style="list-style-type: none"> (i) you contest the accuracy of the personal data; (ii) Sodexo no longer needs the personal data, for the purposes of the processing; (iii) you have objected to processing for legitimate reasons.
Right to data portability	<p>You can request, where applicable, the portability of your personal data that you have provided to Sodexo, in a structured, commonly used, and machine-readable format and you have the right to transmit this data to another Controller without hindrance from Sodexo where:</p> <ul style="list-style-type: none"> (a) the processing of your personal data is based on consent or on a contract; and (b) the processing is carried out by automated means. <p>You can also request that your personal data be transmitted to a third party of your choice (where technically feasible).</p>
Right to object to processing for the purposes of direct marketing	<p>You may exercise your right to unsubscribe to the processing of your personal data e.g. for the purposes of profiling or marketing communications. When We process your personal data on the basis of your consent, you can withdraw your consent at any time.</p>
Right not to be subject to automated decisions	<p>You have the right not to be subject to a decision based solely on automated processing, including profiling, which has a legal affect upon you or significantly affects you.</p>
Right to lodge a complaint to the competent Supervisory Authority	<p>If you have a privacy-related complaint against us, you may complete and submit the Request/ Complaint Form or make your complaint by email or by letter in accordance with our Global Complaints/ Request Handling Procedure.</p> <p>If you are dissatisfied with our response, you may then seek further recourse by contacting your competent Supervisory Authority- the Information Commissioners Office (ICO) https://ico.org.uk/ or the competent court. You can also contact our lead Supervisory Authority, the French Supervisory Authority (the “CNIL”, www.cnil.fr).</p>

You also have the right to ask us not to process your personal data for marketing purposes. Save where legitimate interest applies as referred to above, We will give you an opportunity to consent to us using your data

for marketing purposes and to us disclosing your information to any third party for such purposes. You can exercise your right to prevent such processing by checking certain boxes on the forms We use to collect your data.
